Purchasing art from the annual Art in Healthcare exhibition is a great way to support the work of our important national charity. As you enjoy the new work of art you purchase for your home, your office or as a gift, you will be reminded that engaging with art can have lasting benefits for health and wellbeing.

Art in Healthcare is based in Edinburgh and is a national charity serving the whole of Scotland. We have expertise in how art can impact positively for health and wellbeing and offer services and advice to other health charities, arts organisations and the NHS.

Art in Healthcare offers a range of services: loaning works of art from our collection to improve the healthcare environment, art workshops, commissioning art for healthcare buildings and providing advice, support and consultancy. Our work to humanise healthcare environments includes installing art from our collection of over 1,600 works of contemporary art in a wide range



of healthcare settings around Scotland, including hospitals, care homes, hospices and treatment centres.

We work in partnership with other charities to develop and deliver bespoke programmes of art activity for people with health conditions. This often involves a series of art workshops led by a professional artist concluding with a celebratory event. Our Big Lottery Fund project uses a social prescribing model where individuals are referred to our community-based art activity by their GP, social worker, housing officer or other healthcare worker.

Art in Healthcare does not receive core funding from the Government nor any regular funding from Government-supported agencies. Our income comes from trusts and foundations, artwork loan contracts, events and sales, Friends subscriptions and sponsorship. The annual exhibition is an important contributor to our fundraising and would not be possible without the support of the artists and our sponsor, BTO Solicitors LLP.

Our partnership with BTO is in its third year and we are delighted to be presenting this exhibition with their support. In addition to the exhibition, BTO is also supporting Art in Healthcare to further develop our services for people affected by dementia. This will include a dementia-friendly tour of the exhibition and a programme of work with a care home in Paisley in which we will install art from

our collection and work with staff at the home and BTO staff to develop a programme of art workshops for the residents.

I hope you will enjoy the exhibition and find something that you would like to own. Ask us about the Own Art scheme, which can enable you to pay for your purchase over a ten month interest-free period. 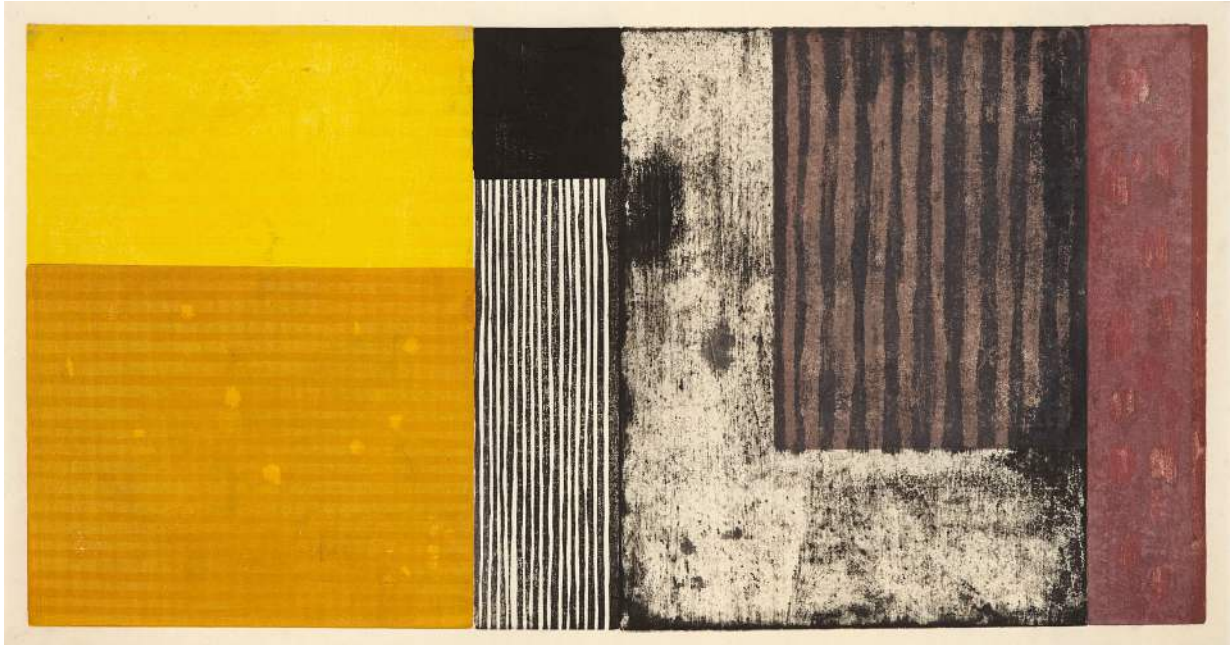

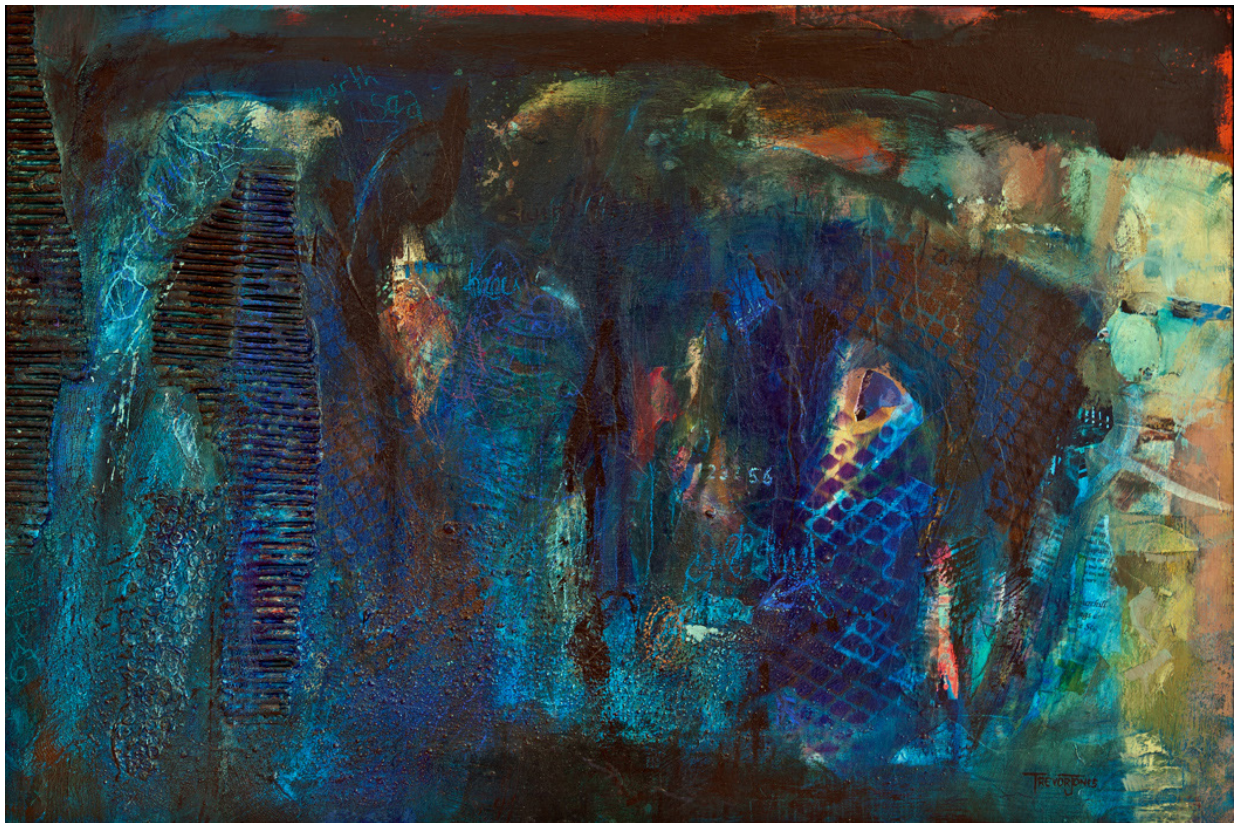

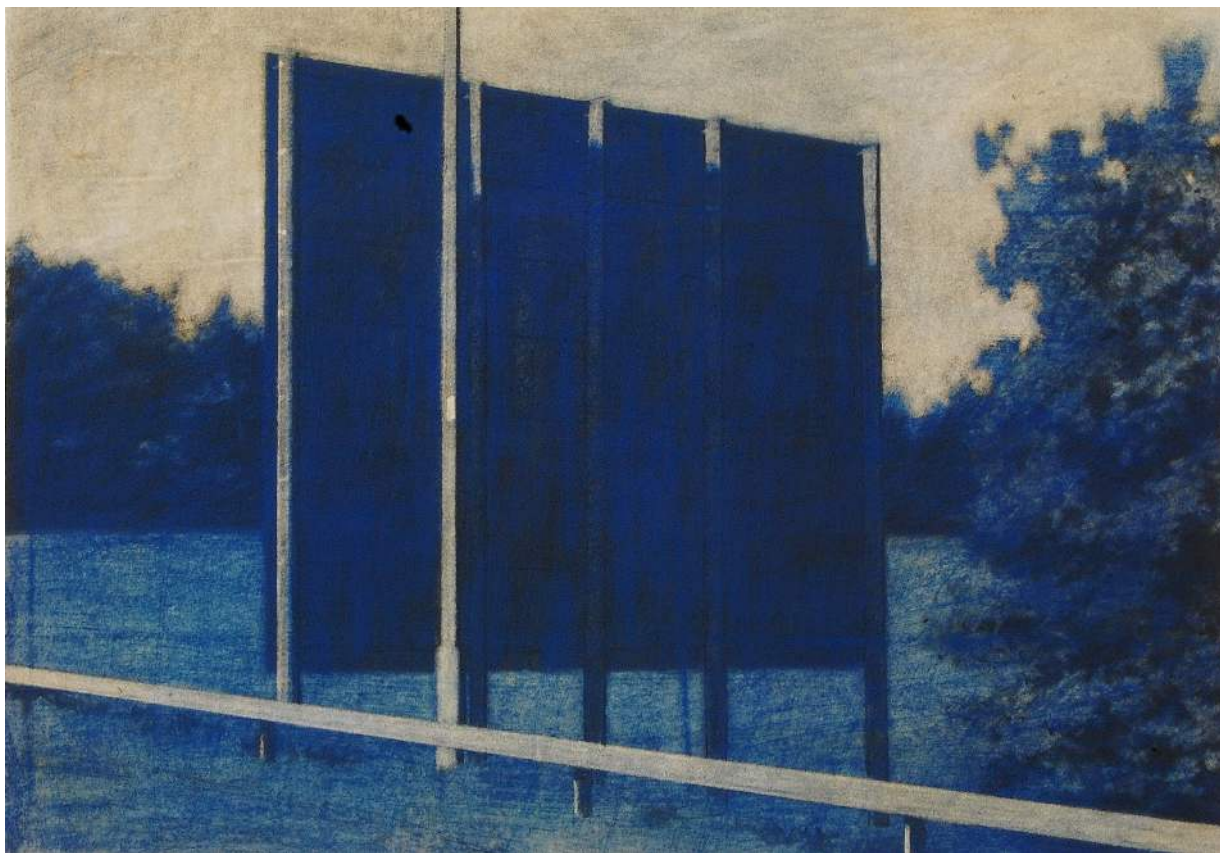

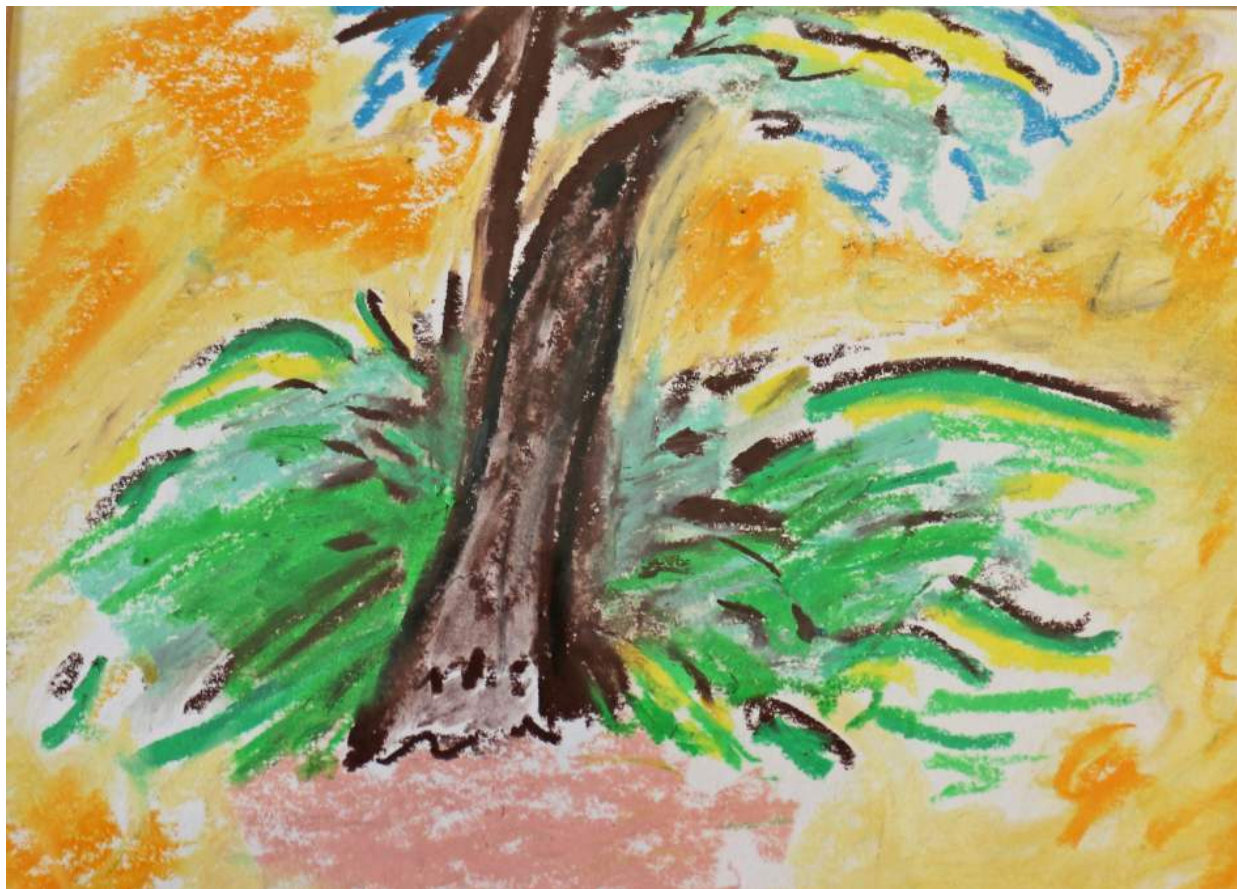

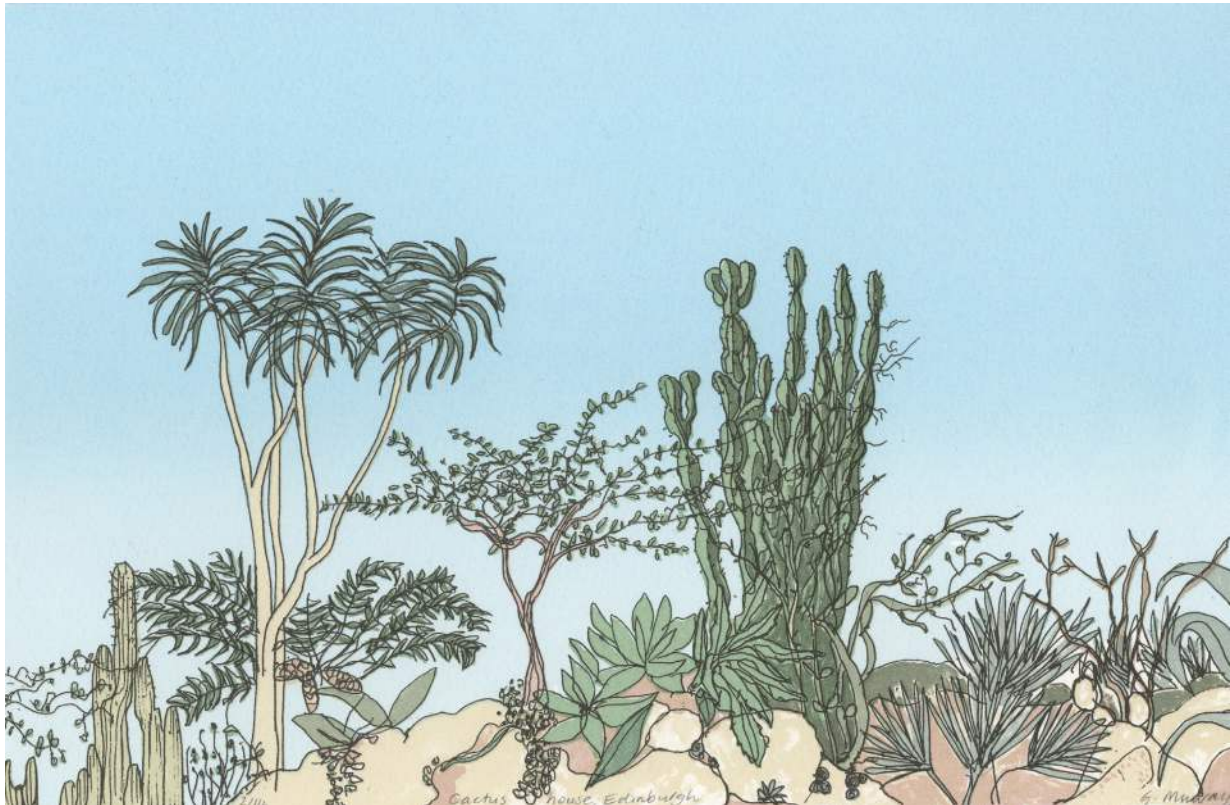
